1. Load-in is available from 4PM – 10PM Friday, October 13, and 6:00 AM – 9:00 AM Saturday, October 14. Please indicate an approximate set-up time in the space provided above. No cars after 9:30 in the fairground, parking will be only available in the front parking lot. _____
2. All tables must be covered to the floor on all sides visible to the public. _____
3. Vendors are prohibited from early dismantle (no boxes/equipment brought in or out), and no preparations are allowed before the close of the Festival at 8:00 PM on Sunday, October 15. _____
4. If the Festival is sold out, you may place your name on a waiting list with no deposit required. To place your name on the waiting list, you may contact Erika Klatyik at (941) 320-8253 or mail@gffusa.org. _____
5. Smoking is not allowed in the tents or vendor areas. _____
6. Vendors are responsible for paying Florida Sales Taxes. _____
7. Upon arrival, check in at the Information Booth. Space numbers are subject to change. You must be completely set up by 9 AM on Saturday, October 14. _____
8. Vendors are prohibited from displaying or selling any objectionable materials or items (i.e., sexually explicit materials or signage, etc.) _____
9. All PERSONAL tents over 10 X 10 must have a Certificate of Flame Resistance in order to obtain a tent permit. _____
10. Please furnish a copy of your insurance information if you sell food products (Naming Sarasota County Agricultural Fair Association Inc. as additional insured) and you're working permit with your signed contract. _____
11. Vendors prohibited bringing any kind of alcohol to the festival area. You could be dismissed if we find alcohol in you tent. _____
12. Please take the festival tickets from guests, we will exchange them the end of the day. Please count them and have them as 500 per envelope (available at ticket booth) _____
